## La Mesa Chamber 2010 Honda CR-V Drive Away Raffle

**RULES:** 2010 Honda CR-V Car Raffle benefiting the La Mesa Chamber of Commerce, of 8080 La Mesa Blvd. #212 La Mesa, CA 91942. La Mesa Chamber of Commerce of La Mesa, CA will conduct the 2010 Honda CR-V Car Raffle (the 'Raffle') as described in these rules and in more detail on the raffle website. By purchasing a Raffle Ticket, each participant acknowledges that such participant has read, understands and agrees to be bound by the terms hereof.

1. **Grand Prize.** The grand prize (Grand Prize) is a 2010 Honda CR-V Base Package with an approximate value of \$22,255. Winner will have a choice of taking the car or \$15,000 in cash. Only one Grand Prize will be awarded subject to these rules. The Prize is provided to La Mesa Chamber of Commerce of La Mesa, CA for purposes of this Raffle by DCH Honda of Lemon Grove. Second Prize will be \$2,000 and third prize will be \$1,000. There will also be a \$3,000 early bird drawing on August 15<sup>th</sup> for tickets sold by July 30<sup>th</sup> and a \$3,000 Refer a Friend (Friend must be a ticket raffle holder) drawing to be held on Friday January 7, 2011.

2. **Raffle Tickets.** Raffle tickets ('Raffle Ticket') cost \$25.00 per Raffle Ticket. You may also purchase ticket packs in multiples of 5 tickets for \$100 each **to a single purchaser.** Raffle Tickets may be purchased in person, by fax or by phone from an authorized representative of La Mesa Chamber of Commerce of La Mesa, CA. Raffle tickets may be purchased with an authorized and approved Visa, Discover, Amex or MasterCard credit card transaction, with cash or by personal check made payable to La Mesa Chamber of Commerce of La Mesa, CA. If a participant's check is dishonored for payment by their bank for any reason, or, should the Visa, Discover, Amex or MasterCard banking institution decline the credit card charge for any reason, the participant's Raffle Ticket(s) will be declared an invalid entry and deemed void. By purchasing Raffle Tickets, the participant understands and agrees that La Mesa Chamber of Commerce of La Mesa, CA will not be responsible for any errors in credit card approval and/or bank check processing. If 2,000 tickets are not sold to cover the cost of the raffle prior to the date of the drawing, the Grand prize will be limited to a cash payment of \$7,500. All other prizes will remain the same.

4. **Drawing.** The Grand Prize, Second and Third Prize winner will be determined by a random drawing on Friday January 7, 2011, at 2:00 PM. Deadline to enter is Thursday December 23, 2010. The winner of the Prize drawing will be notified by La Mesa Chamber of Commerce of La Mesa, CA as soon as possible following the drawing. The prize will be awarded as soon as the Eligibility Requirements for the Grand Prize, second prize and third prize as set forth herein, are met. Winner does not need to be present at the time of drawing to win.

5. **Publicity** By participating, where allowed by law, all participants and winners grant the La Mesa Chamber of Commerce of La Mesa, CA the exclusive permission to use their names, characters, photographs, voices, and likenesses in connection with promotion of this, other raffles, contests and waive any claims to royalty, right, or remuneration for such use.

The La Mesa Chamber of Commerce of La Mesa, CA reserves the right to terminate the Raffle and refund all ticket purchases, or make such other decisions regarding the outcome as the La Mesa Chamber of Commerce of La Mesa, CA deems appropriate. The decisions of the La Mesa Chamber of Commerce of La Mesa, CA and its authorized representatives shall be final on any and all matters concerning the execution of the Raffle and the awarding of the prizes.
